郑爽律师发声明否认郑爽虐待或忽视孩子

7日,针对张恒指控郑爽虐待孩子一事,郑爽律师发布声明称:"郑爽毫不含糊地否认她曾经虐待或忽视她的孩子。"同时透露孩子们快乐健康,张恒所说为不实之词。

Shuang Zheng unequivocally denies she has ever abused or neglected her children. At this time, there are no criminal, dependency and neglect, or Child Protective Services cases that have been filed. The only "investigation" of which we are aware is a residential visit our client received on January 4, 2022 that lasted approximately five minutes. During that visit, police found the children to be happy and healthy and when asked if further investigation was necessary, the police declined.

In March 2022, the Court ordered that the father may not relocate to China with the children. The Court also substantially increased our client's parenting time with the children including awarding her overnight parenting time every week. Father's false allegations of abuse began following his Court losses. When his case became unsuccessful in Court, the father apparently turned to trying his case in the Court of public opinion by staging a press conference in California to spread untruths about our client.

The children are currently happily in our client's care in Colorado while the father left the state to attend his "false allegation" press conference in California.

2022年3月,法院下令,父亲不得带着孩子移居中国。法院还大幅增加了我们的客户与孩子的育儿时间,包括每周给予她过夜育儿时间。父亲在法庭上败诉后,才开始诬告虐待。当他的案件在法庭上不成功时,这位父亲显然转向在舆论法庭上审判他的案件,他在加利福尼亚州举行了一场新闻发布会,散布有关我们客户的不实之词。

孩子们目前在科罗拉多州快乐地接受我们委托人的照顾,而父亲则 离开了这个州,去加利福尼亚参加他的"虚假指控"新闻发布会。
