

LCK : BRO vs KT的两名助理裁判处以10场禁赛处罚 并参加培训

在2月5日LCK春季赛BROvsKT的赛后，BRO官方发布抗议官方赛前的通知有误，事后LCK官方也发文进行了道歉，在经过调查后，LCK官方发布了对BRO和KT当值的两名助理裁判的处罚。

细节

每场比赛的主场队必须在比赛前三天17:00之前，在联盟管理的电子表格上填写他们的选队名单。LCK助理裁判检查主队的选边，更新表格以供客场队查看，并再次检查表格是否正确填写。

在KT对BRO的比赛中，主管助理裁判意外地在电子表格中填写了KT为另一场比赛选择的选项，而负责检查的人由于当天有其他工作而错过了错误。

最后，由于观众在网上等待，直播如期开始，并根据与BRION的讨论结果调整游戏的实际开始时间。然而，在进行讨论时，这些信息没有正确地传递给竞技场管理团队。队员们排成了一排，BRION被迫迅速做出决定。

预防措施

到目前为止，选边由一名裁判负责，但现在将由两名裁判负责。除了在每个队可访问的当前电子表格上填写边选择信息之外，LCK和韩国电子竞技协会（KeSPA）的一名裁判将通过电子邮件直接向两队宣布选边。

纪律处分

正如KeSPA所宣布的，两名助理裁判均被KeSPA裁判委员会处以“10场禁赛”的处罚，并将参加培训以防止再次发生。



DETAILS

Each match's home team is required to fill in their side selections on a spreadsheet managed by the league by 17:00, three days before the game. An LCK assistant referee checks the home team's side selection, updates the sheet for the away team to see, and double-checks that the sheet is filled out properly.

For the KT vs BRO match, the assistant referee in charge accidentally filled in the spreadsheet with the selection picked by KT for a different match, and the person in charge of checking missed the mistake due to having other work on that day.

Finally, due to viewers waiting online, the broadcast planned to start as scheduled with the actual start of the game adjusted following the results of discussions with BRION. However, while discussions were taking place, this information was not delivered properly to the arena management team. The players were lined up, and BRION was forced to make a quick decision.

FOLLOW-UP

Prevention Measures

Until now, side selections were handled by a single referee, but now two referees will be in charge of the task. In addition to filling out the side selection information on the current spreadsheet accessible to each team, the LCK and a referee of the Korea e-Sports Association (KeSPA) will directly announce side selections to both teams by e-mail.

Disciplinary Actions

As announced by KeSPA, the two assistant referees each received a "10-game suspension" by the KeSPA referee committee and will attend training to prevent reoccurrences.

We'd like to take this opportunity to apologize once again to BRION and BRION fans. We will thoroughly check key information delivered to each team and prevent the same problem from happening again. - LCK
